The Issuer hereby gives notice pursuant to Art 18(2)(a) of the Transparency Directive (2004/109/EC) and sub-Article 6(h) of the articles of association relating to the Preferred Securities (the "Articles of Association") that HYPO ALPE-ADRIA-BANK INTERNATIONAL AG has given notice to it of a balance sheet loss (*Bilanzverlust*) for the fiscal year 2010 and that due to insufficient Distributable Funds (as defined in the Articles of Association) the dividend payments on the Preferred Securities scheduled for 13 July 2011, 13 October 2011, 13 January 2012 and 13 April 2012 will not be made, except that the dividend payment scheduled for 13 April 2012 may be made if HYPO ALPE-ADRIA-BANK INTERNATIONAL AG has given notice to the Issuer of a balance sheet profit (*Bilanzgewinn*) for the fiscal year 2011 resulting in sufficient Distributable Funds available to pay the dividend on 13 April 2012.
